



Club Opening and Closing

Contract Period:

Club operates May 1st to October 31st under agreement with the City.

Liability Risks:

Operating beyond the season without water or maintenance increases legal exposure under Ontario's **Occupiers' Liability Act**.

Uninsured Negligence:

Continuing beyond the City's closing period risks negligence claims not covered by insurance. There will be no property insurance and the Club will need to cover any damages as confirmed via email August 30,2024

Waivers Not Sufficient:

Waivers or "play at your own risk" policies don't fully eliminate liability for unsafe conditions.

Unattended Facilities:

Without staff or water, we cannot ensure safety, increasing financial and legal risks.

- Orderly Closing:
- Closing when the water is shut off helps to ensure an orderly and planned closing while ensuring courts are not damaged by excessively dry conditions
